### **Old Business:**

Bill Ruelle was welcomed to the CC filling the vacancy left by Matt Mead. Matt Mead was welcomed as the BOD liaison to the CC.

## Regular Item Reports:

Lakes/Dams/Fish: Nothing new to report- Ed

Sharee states that Sharbonneau Excavating will be monitoring the Pole Swamp overflow tube situation.

**Budget**: Dan F. awaits amended budget for 2016 and asked Liaison Mead for the 5 year and 20 year budget forecasts as it pertains to Conservation.

**Fields:** Big Don from maintenance attended and provided a lengthy discussion on fields @ LLWC.

Six fields- 29,3,5, 6,7,62 are ready for frost seed of red/white clover totaling 6.2 acres. Work order # 866730 has been sent.

Also, an estimate of \$1500 was given for rebuilding the sprayer and a need for new tractor tires.

**Timber:** Scott reported on status of the 2015-16 timber cut, harvesting is complete on units 1,4,5,6 but significant hauling remains to be done. Units 2 and 3 remain in progress. The temporary bridge over the flowage in Unit 3 will be removed upon completion. Terry Manty (Grossman Forestry) will be at the April CC meeting. Discussion on time/date to do a woods tour ensued.

**Turkey Feeders:** Lydia Lucas reporting for Dave L. said the feeders were filled again within the last week.

Future Planning: Nothing new to report says Bob S.

**Pheasant shoots:** Mike reports an upcoming shoot with near 20 hunters.

**Surveys:** Dan G. explained the membership survey and asked for volunteers.

**Hunters Round up:** Dan G. has the information on the lucky hunters from 2015 and will make contact.

He also contacted SCI about the raffle license.

**Articles:** Ideas for articles were discussed, Scott with a DEER grant article and Greg with a fields article were top ideas.

**Outside Resources**: Ducks Unlimited is returning to LLWC with a sportsman's banquet fundraiser in September. Scott reported that there is a RGS banquet in Alpena on April 2, 2016.

**Forest Health Issues**: The quarantine area out near the west gate is still under observation. Nothing new to report

**Blind Committee:** Dan G., Bill, and Dan F. will be point persons for this (re)newed Committee.

It was discussed that Management maintains GPS data on blind locations but the Blind Committee will settle disputes. Dan F. will review the GPS data for any improvements and/or modifications.
