Presidents POV (Point of View)

My Grandpa knew everybody....

Or so I thought.

Like many of you, our family history at Lost Lake goes back a long way. My Grandparents joined LLWC in 1951 after having a cabin on Hubbard Lake for many years before that. I came around in 1958 (my sister calls it ‘Black Wednesday’) and since then I’ve been coming to the club my entire life.

Grandma and Grandpa built two cabins at the club. The first cabin is on the NE corner of Fox and Pheasant, and the second one is the yellow house on the SW corner of Fox and Cottontail. They lived at the club most of the year, but like many, migrated to Florida every winter.

As kids, our family lived first in East Detroit then later in Clinton Township but we went to the club often to visit my Grandparents. It was always great fun and we would fish and hunt, swim, shoot, and just relax. Even though we went there several times a year, it never seemed to be enough. But when we got there, we made the most of it. We went to the range to poke holes in paper, spent a lot of time on Lost Lake catching huge pike (they’re still there by the way), checked in on the hunting blinds, and swam at the beach. Grandpa and Dad would golf from time to time and Grandma always had a cookie jar with home baked cookies.

Grandpa would often take us grandkids for drives through the woods looking for deer, or to one of the lakes to fish, and strangely what I thought was a highlight errand to run, was taking the garbage to the dump so we could watch the bears pick through what we humans didn’t find appetizing.

But during these excursions around the club, one thing that amazed me as a young boy was that Grandpa seemed to know everyone at the club. As we drove around, or spent time cleaning up the yard at the cabin, or walked to the beach, he always waved to anyone that went by. There wasn’t a car that passed us that Grandpa didn’t wave to whoever was driving.

Most times I didn’t notice or give it a thought, it was just something he did. But sometimes I would ask him “Grandpa, who was that you waved to?” He would usually tell me a name, or maybe say that was so and so from the golf course, or maybe he would identify them by what cabin they owned. It didn’t matter who it was that went by, he waved. Not a big overhead wave, just a friendly ‘hello’ type of wave. Sometimes it was just his hand that was holding the steering wheel of his old Ford that would pop up in a sort of half wave, but he acknowledged them all as we slowly passed in the woods.

There were times it seemed that me made up names, I will never know for sure, but at the time some of the names seemed made up to me. And sometimes, not too often but sometimes, when he told me who it was, there were some pretty unkind comments that followed along about who that guy was or what he did. But they still got a wave (you would have to have known my Grandpa).

But one thing I did learn to do at a young age was to begin waving at everybody I passed. After a short while I found this pretty fun. What was cool was that a lot of people waved back! Even the adults waved to me, a little kid that didn’t know these people, would get a wave and smile! I would wave just to see who would and would not return the gesture. It was fun! Call it my Forest Gump moment.

As the years went by it just continued without a thought. It became a habit that I picked up and to this day I wave to just about anyone that I pass, be it in the woods, along Fox Road, or wherever on the property.

What else was strange was that once we left the property, we didn’t wave to people. It was sort of a special private privilege reserved for Lost Lake members.

Here’s what’s cool. My two oldest grandsons, Alex and Justin, members themselves along with their parents, have picked up on this habit. They haven’t asked me about it yet, but when we drive around the club or through the woods, they wave to people right along with Grandpa. This little gesture of friendship has made it a couple of generations. That’s cool if you ask me.

Today, I would say that about half the people I wave to on the property wave back. I would love to see that increase. It’s a friendly gesture amongst the LLWC family, costs us nothing, takes no time or effort at all, and can easily bring a smile to your face.

So next time you cross paths with a fellow member, smile and wave. Most times you’ll get one back. And you might just bring a smile to a young boy or girl’s face, and that my friends, is priceless.

# What’s So Invasive about Invasive Species? Part One

The days are getting longer, the snow is beginning to melt, and there is mud *everywhere*. Mother Nature is shedding her winter coat with signs of new growth budding in the trees and poking up through the soil. Animals are moving into different habitats to find food and perform spring courtship rituals. Dormant plants are awakening to compete for light and nutrients. What happens to all of these plants and animals if a new species moves in?

The general phrase “Invasive Species” has been prevalent in the media over the last few years. The ongoing threat of Asian Carp in the Great Lakes has placed invasive species awareness in the spotlight; however, invasive plants, animals and insects have been here for decades. In some cases they have been established for centuries. We encounter these plants and animals on an almost daily basis without realizing that they impact our natural surroundings on a local, state, and global scale.

Invasive species are species of plants, animals, or insects that are not native to a particular habitat and are likely to cause harm on an environmental or economic level. Available to you is a variety of thick, weighty volumes brimming with dry scientific verbiage dedicated solely to identifying all the horrific degrees of disaster each species is capable of reaping in your own backyard. While that may be stimulating reading for some, let’s take a more manageable approach to understanding what is invasive and why controlling them is important. Invasive species all share two common themes: They are able to outcompete native species for resources such as food or light and they have a negative impact on the plants and animals in the habitats where they become established.

You may be wondering what the big deal is if we already co-exist with these so-called invasive species. The U.S. Fish and Wildlife Service estimates that there are over 50,000 non-native species (this includes animals, plants, and insects) in the United States and that over 4,300 of these non-natives are considered invasive. The breakdown: only nine percent of non-native species in America are considered invasive. Now, nine percent isn’t a number that makes us jump up off the couch and join our local conservation group. What these numbers don’t communicate is the distribution and impact of that nine percent. I was unable to find neat and tidy figures for Michigan, but we can bring it down to a local scale on our own.

Let’s theoretically introduce an invasive plant to Lost Lake Woods Club that volunteers in areas of Michigan have been battling for years: Garlic Mustard (*Allaria petiolata*). I chose this particular species for three reasons: it is an invasive that can become established in undisturbed environments, it occurs on both Peninsulas, and its impacts have been researched and documented. If you walk into any forested stand on Club property, how many different plant species do you expect to see? You might count two to four different tree species and ten to fifteen herbaceous (non-woody) species. Introduce Garlic Mustard and year after year the number of herbaceous species such as Trillium and Violets would begin to decrease. Soon the seeds from

the tree species are no longer sprouting. What you then have is a forest with a sea of Garlic Mustard covering the ground. This is called a monoculture and is a common result of invasive plants becoming established in an area. The Garlic Mustard plants are not only outcompeting native species for light and soil moisture but are releasing a biochemical into the surrounding habitat that changes the chemistry of the soil. This chemical change impacts the native plants that have historically grown there and alters what types of insect and amphibian species are able to utilize this habitat. It may still look like a forest of green plants with mature trees, but this one plant species has now affected the entire food web. Animals that feed on insects and amphibians will move to another area. Birds that prefer different heights of trees for nesting no longer have a sub-canopy or shrub layer to choose from. The biodiversity of this habitat becomes severely degraded. A problem with invasive species is that they are opportunistic; they aren’t satisfied by settling in one place and continue to spread if allowed to.

Enough with the gloom and doom; you can see how the process works. Does this mean that all of our native communities, particularly our treasured ten thousand acres beyond the Woods Gate, are destined to go the way of the Dodo? Absolutely not. Why? Simply because we know better. The first step is to educate ourselves on how invasive species impact habitats. We can now check that off of the list! The next step is exploring what invasive species we already have established on the Club and what the impacts are. We are all Stewards of the land and understanding the role of invasive species as part of our natural resources gives deeper meaning to what we value. Next month we will be identifying a handful of common invasive species that we encounter every time we head out into the woods. Stay tuned!
